## Citadel Securities PhD Poster Session Awards Participant Certification ("Certification")

- **I.** By submitting an application, you certify, affirm and agree that the following statements are true as a condition of participation:

# LONDON PHD SUMMIT POSTER SESSION COMPETITION OFFICIAL RULES

This is a closed Competition only open to PhD candidates participating in Sponsor's London PhD Summit, who are currently enrolled and in good standing with their respective universities.

No purchase necessary to enter or receive an award. A purchase will not increase your chances of receiving an award. Void where prohibited by law.

The London PhD Summit Poster Session Competition (the "Competition") is sponsored by Citadel Securities Europe Services Limited and Citadel Management (Europe) III Limited (collectively, "Citadel Securities" or "Sponsor").

You are prohibited from submitting any confidential information in this Competition or any original content that you wish to keep confidential.

Prospective participants must apply to and be selected for the Competition. By participating in the Competition, you agree to these Official Rules, which are a contract, so read them carefully before taking any action to participate. Without limitation, this contract includes indemnities to Competition Entities from you, a limitation of your rights and remedies, and waiving class action claims.

#### **SUMMARY**

The Competition invites individual eligible participants to present academic research in the form of a poster. Posters will be evaluated by quantitative researchers from Sponsor who will select three (3) winners. Winners and their academic departments will receive the awards set forth in these Official Rules.

#### Eligibility

Sponsors offers a two-day Competition in London with specific eligibility for the Competition set forth on the Competition website. All applicants must be at least eighteen years of age and the age of majority in their jurisdiction of residence at the time of application and be either a permanent legal resident of the United Kingdom or a nonresident student temporarily in the United Kingdom on a student visa. In addition, all participants must be enrolled as a PhD student and in good standing with their respective university. Employees, officers, directors, members, managers, agents, consultants and representatives of Sponsor or its affiliates are not eligible. **Participants must be available to participate (and travel, if applicable) on the dates set forth on the Competition website.** 

As a condition of participation, each participant agrees to provide Sponsor with all requested documentation or other proof of eligibility within the specified timeframe. Sponsor reserves the right to disqualify at any time any participant who does not meet the eligibility criteria described in these Official Rules or the Competition website or who has otherwise violated these Official Rules, even if they have been approved for Competition.

As a condition of applying, you hereby agree to read, complete, agree to, and sign additional documentation that, among other things, provides information for tax and legal compliance purposes, grants Sponsor certain licenses, and confirms the requirements and conditions for Competition participation, if selected as a Competition participant. This may include additional releases and documentation to provide travel and accommodations for Competition attendance.

## **Application and Selection Process**

Applicants must submit their completed application to the Competition during the application window set forth on the Competition website. To apply, an individual can access the application through the Competition website and follow the on-screen links and instructions to complete and submit the Competition application form and provide all required information before the application deadline, which may include information about you, a resume, representative work experience, and personal information such as first and last name and email address

("Applicant Content"). Your Applicant Content must be truthful and accurate and you must provide all required information or your application will not be considered.

You are solely responsible for complying with all applicable federal, national, state, and local laws, rules, and regulations in connection with your application for the Competition. Proof of application (such as a screenshot of your application) does not constitute proof of actual receipt. Applications will not be returned. Keep a copy of each element of your application. Applications that are incomplete, illegible, corrupted, damaged, destroyed, altered, false, lost, late, misdirected, garbled or otherwise not in compliance with these Official Rules will not be accepted and will be void.

Following the application submission deadline, Sponsor's hiring committee will select applicants to participate in the Competition based upon each applicant's academic performance, qualifications and demonstrated interest in the investment field.

Selected applicants will be notified on or around the notification date set forth on the Competition website. Potential participants will be required to respond to Sponsor's notifications, provide required information and complete required paperwork in accordance with Sponsor's instructions and stated deadlines to remain eligible for the Competition. Potential participants may be required to complete and return tax forms to Sponsor in accordance with Sponsor's timing and instructions or participation and/or any prizes won may be forfeited.

### **Travel Benefits**

Competition participants will each receive roundtrip economy-class airfare from an airport near participant's home in Europe, ground transportation to and from the arrival airport, single occupancy hotel accommodations and meals during the Competition days. The total value of Competition travel benefits (excluding any prizes won) is approximately 80 GBP and will be confirmed by Sponsor during Competition enrollment. Any taxes (federal, state and local) and other costs and expenses associated with Competition participation will be the sole responsibility of the participant. Participants may be issued an IRS 1099, IRS W-8 BEN form, or other applicable foreign tax form, in Sponsor's sole discretion. All Competition benefits are subject to these Official rules and any specifics not set forth in these Official Rules will be determined in Sponsor's sole discretion.

# **COMPETITION DATES**

The Competition consists of a two hour presentation window with an abstract submission ("Poster") deadline of 3:00 pm BST on March 8, 2024 ("Abstract Submission Deadline"), with full participation details to be provided by Sponsor at the Summit. Participants will be required to present their Posters during in person presentations that will begin at 1:30 pm BST on March 8, 2024.

Posters will be judged by Sponsor Quantitative Researchers and will be judged on (1) Technical Complexity (2) Applicability and (3) Presentation.

Sponsor will award awards to winning individuals, following verification, in accordance with the award descriptions set forth below, as well as a corresponding grant to the winning individual's academic department at their university.

All award payments will be awarded to the winning individuals and their respective academic departments in the form of paper checks within 3 weeks of the Summit. Research grants are unrestricted and will be awarded directly to the university.

Winners may be required to complete tax paperwork, as required by Sponsor, in order to receive an award and may be issued an IRS 1099 or comparable foreign tax form for the ARV of the award. All award details not specified in these Official Rules will be determined in Sponsor's sole discretion. No award substitutions permitted except at the sole discretion of Sponsor, in which case an award (or portion of the award) of equal or greater value may be awarded. Sponsor may be precluded from awarding awards to nonresident students for regulatory or other reasons, to be determined by Sponsor in its sole discretion according to its usual business practices. # **WINNER NOTIFICATION & VERIFICATION**

Potentially winning individuals will be notified at the conclusion of PhD Summit, March 8, 2024. If any award, award notification or Competition-related communication is rejected, faulty, or returned as undeliverable, if the potential winner does not respond or only partially responds according to the notification's or Sponsor's instructions, if a potential winner cannot attend or participate in any portion of the Competition, if any participant fails to comply with these Official Rules, or if a potential winner cannot be reached after a reasonable attempt has been made by Sponsor (as determined by Sponsor in its sole discretion), the potential winner may be disqualified (regardless of whether it has been announced anywhere) and an alternate winner may be selected in accordance with the winner determination procedures described above, in Sponsor's sole discretion.
